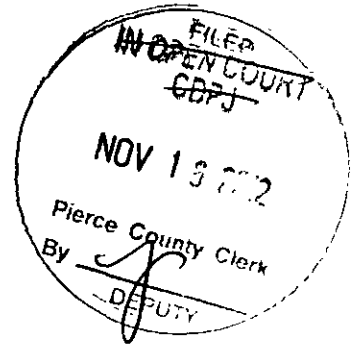




The opinion of the Supreme Court of the State of Washington was filed on June 28, 2012.
